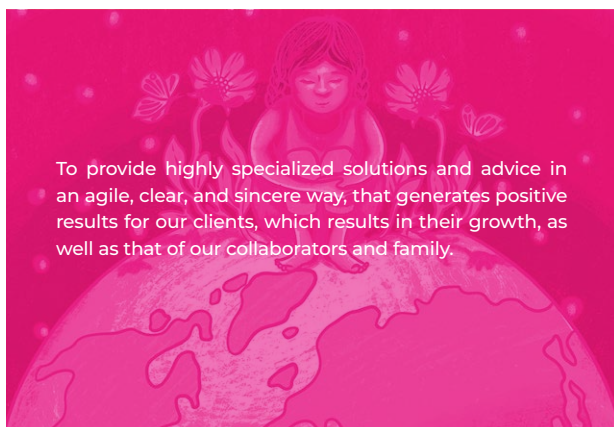

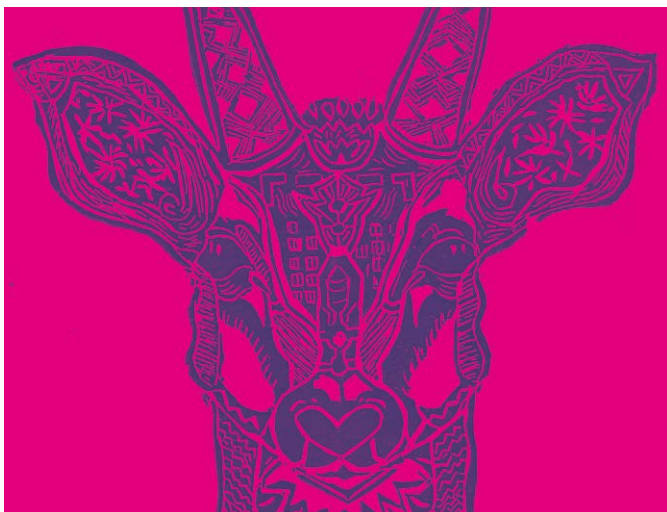

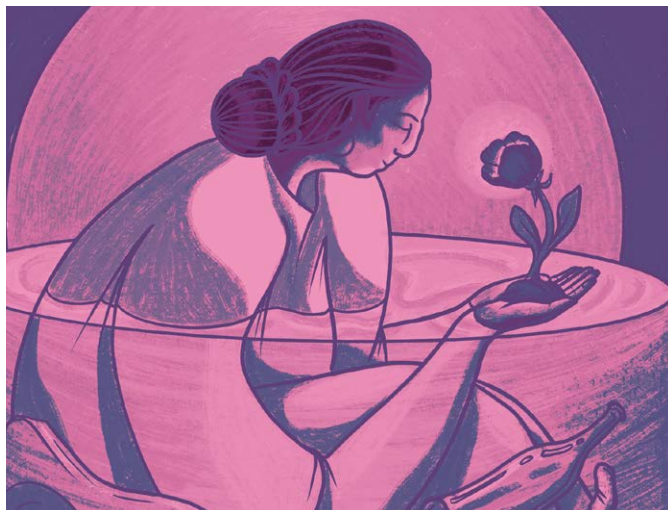


COMPLIANCE

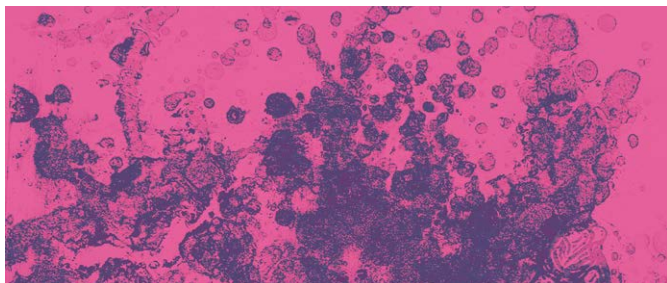

- ▼ Permanent Resident Visa. Applicable to foreigners with temporary resident status who have completed four consecutive years of residence in the country
- ▼ Visa by Family Unit. Applicable to a Mexican or foreign person holding the status of temporary resident or permanent resident who requests a visa for a foreign person with whom they prove to have a direct family relationship

In this context, **bgbg** has committed to providing pro bono services to sectors of the Mexican population that are in vulnerable situations and, therefore, lack the necessary or sufficient resources to access quality professional services.
